#### **Questions were raised**

- a) about the importance of MWT's nature reserves and whether this was recognised in the strategy. In summary their importance is recognised, and they will continue to play a key role however to achieve 30% of land managed for nature influencing and advice are also important as acquisition of sufficient land would be impossible not least because of the ongoing management costs
- b) **about MWT's position regarding the plans for a Ramsey Marina**. In summary MWT will take an evidence-based view whilst being sensitive to the controversial nature of the plans. MWT may take on ecological assessment work if asked to do so as it was better for MWT to carry out this work rather than a firm from off Island. However even if the consultancy work was provided MWT's position would be unaffected and remain focussed on the environmental impact
