## Wildlife Challenge Competition 2023

## Terms and Conditions

This competition is operated by Love Tech Limited, an Isle of Man charity with charity number 1293, UNESCO Biosphere Isle of Man and, Manx Wildlife Trust an Isle of Man charity with charity number 225, collectively referred to as "We, "Us" or "Our.

This competition opens on 1/8/23 and closes on 30/9/23 (the "Competition Period"). Only entries submitted within the Competition Period will be valid and eligible for competition entry.

ENTRANTS ELIGIBILITY: This competition is open to all under 8–12-year-olds residing in the Isle of Man.

All entrants must have parental or guardian consent. By entering this competition, each parent and guardian will be deemed to have consented for the applicable entrant's details to be used in accordance with these terms and conditions. The winner may be asked to provide proof of age and written parental or guardian consent when claiming their prize.

Entries should be submitted via the form on the Manx Wildlife Trust Wildlife Challenge Web Pages.

Maximum of one entry per person.

The entrant with the winning pledge will receive an Apple iPad mini  $-6^{th}$  generation, two runners up will each receive a £50 voucher for the MWT Peel Gift Shop, 7-8 Market Place, Peel, IM5 1AB. There is no cash alternative and vouchers are non-transferable.

WINNER SELECTION: Judging of the competition will take place within 31 days of the closing date. All entries will be assessed, and winner chosen by a representative from each of Love Tech, Manx Wildlife Trust and UNESCO Biosphere Isle of Man.

We will contact the winner by email within 5 days of the judges selecting a winner. If a winner does not respond to us within 10 days of being notified by us, then the winner's prize will be forfeited, and another winner will be picked from the remaining shortlisted entries.

If there is any dispute about the validity of any entry or any other aspect of the competition, this will be decided by us. The judges' decision in relation to the winner is final and binding. Our decision regarding any other aspect of the competition is final and binding.

The winner's first name and winning entry will be published on Our webpages, social media and in promotional materials. We would like to take a picture of the winner, but no winner is obliged to have any picture taken and the consent of the parent and guardian will always be required in this event.
